## Under 1 Roof working with Q Shelter to share learning and development opportunities

As you may know, Under 1 Roof has been offering learning and development events since 2010 and Q Shelter plays an important state-wide capacity building role in the community housing and homelessness sectors. In recognition of a shared interest in supporting sector development through learning, Q Shelter and Under 1 roof are working together to provide and promote events to a broader audience.
