2. Learn and Share Program

As part of a funded program through the Department of Housing and Public Works, U1R is working to harness learning opportunities that agencies can share. U1R is working to enable information exchanges and linkages with learning opportunities across and between agencies and regions.

Opportunities for sharing learning experiences might include:

- Working with Under 1 Roof to record a podcast or webcast on a topic your agency is skilled and/or experienced in

TIC emphasises the importance of physical, psychological and emotional safety for both providers of services and those receiving care and support. This day-long introductory workshop will give an overview of the following:

◇ The evolution of frameworks leading to the development of TIC

◇ Defining trauma and exploring its prevalence

◇ Exploring impacts of trauma

◇ Elements of the TIC model

◇ Application of these elements to practice

◇ Being a Trauma-Informed service- what does it take?
